## EUROPEAN PEACE FACILITY - 2025 ANNUAL BUDGET FOR ASSISTANCE MEASURES FUNDED UNDER THE EUROPEAN PEACE FACILITY

The European Peace Facility (EPF) was established by Council Decision (CFSP) 2021/509 of 22 March 2021 as an off-budget instrument on the basis of Articles 21(2)(c), 28(1), 41(2), 42(4), 43(2) and 30(1) of the Treaty on European Union (TEU). Its objective is to enable Member States to finance Union actions under the Common Foreign and Security Policy (CFSP) to preserve peace, prevent conflicts and strengthen international security in accordance with the relevant provisions of the TEU, thus acting more swiftly to promote human security, address instability and work towards a safer world. The Facility funds actions which due to their military and defence implications, are not funded under the EU budget.

In compliance with Article 15 Book 3 of the Rules for the implementation of revenue and expenditure financed under the European Peace Facility<sup>1</sup>, this document provides the titles of the EPF budget for assistance measures for the financial year 2025, as modified by the Committee established under Article 11 of Council Decision (CFSP) 2021/509 by amending budget 2/2025 adopted on 16 April 2025.
